

THE SAN DIEGO UNIFIED SCHOOL DISTRICT BOARD OF TRUSTEES VOTED UNANIMOUSLY TO ADOPT OUR RESOLUTION TO CREATE COMMUNITY SCHOOLS IN SAN DIEGO.



VICTORY! On Tuesday July 28th, the San Diego Unified School District Board of Trustees voted unanimously to adopt our Community Schools Coalition Resolution. This is a huge win for our communities!

POLICY ADVOCACY

Workplace Safety

Last week, the County Board of Supervisors [approved a plan](#) that includes 22 staff positions to enforce COVID-19 health orders in public establishments. **This is a big move in the right direction towards safer workplaces, which lowers risk for workers, their families, and the public.**

The county's plan is consistent with the Office of Labor Standards Enforcement (OLSE) we have advocated for at the City of San Diego and County of San Diego through the [Community Budget Alliance](#) and [Invest in San Diego Families](#) coalitions.

We might have reduced the spread of COVID if we already had this office in place to protect workers with PPE, ensured that they knew when they had been exposed to infection at work, and had the ability to stay home if they thought they were sick or knew they had an exposure to COVID. We will continue to advocate for an OLSE to be created.
